Public Attendance:

Five members of the Forum/Public attended the meeting.

1. Introductions and Apologies:

Suzanne Jobson, Chair welcomed everyone to the meeting. Apologies are noted above. Alan Tubman introduced the New Town Clerk Helen Richardson, Helen will take over from Alan at the next Board meeting. The Chair welcomed Helen on behalf of the Board

2. Declaration of Interest:

Board Members were asked to declare any personal or pecuniary interest in relation to the agenda as per the AAP Terms of Reference:

Daniel advised these projects if agreed would be done so in principle by Board members in attendance and followed up with an email to all Board Members.

3. Agreement of the minutes – 12th January 2022 and Matters Arising:

Suzanne asked for agreement of the previous Board Minutes. The minutes were agreed as a true record. Matters Arising – there were no matters arising.

4. County Durham Inclusive Economic Strategy Consultation Presentation:

Glenn Martin, Durham County Council gave a presentation on the County Durham Inclusive Economic Strategy Consultation. He highlighted that last year the new leaders of the County Council identified a gap in the Council's strategy framework and the need for a new Economic Strategy

He advised the main economic strategy that had been in place was the Regeneration Statement which was due to be reviewed or replaced in 2022. He added that several key strategies had recently been adopted by the Council including the County Durham Vision, the County Durham Plan, and the Climate Emergency Response Plan.

He advised that the regional and national policy landscape is very different to when the Regeneration Statement had been developed.

The new leaders of the Council wanted to consult widely and see a different approach to developing this key strategy so we commissioned a branding agency in Newcastle to help us develop the 'Our Big Econ-versation' brand and website. The marketing agency are also helping us to promote the conversation over the coming months.

The Inclusive Economic Strategy will;

- Balance economic growth with the need to reduce carbon emissions and improve socio-economic sustainability
- Define priorities for growth and recovery from Covid-19
- Enhance and create opportunities across the county
- Align with the County Durham Vision 2035, which sets the ambition of generating more and better jobs across the county

To stimulate conversation, the discussions could be broken down into the themes of:

- People (e.g., education, training, jobs, entrepreneurs, careers)
- Prosperity (e.g., innovation, growth, productivity, high-skilled jobs)

- Places (e.g., town centres, business parks, transport, housing)
- Promotion (e.g., to visitors, investors, developers, students)
- Partnerships (e.g., to develop the economy, to tackle deprivation)
- Planet (e.g., lower carbon / net zero, renewable energy, recycling / re-use / repurposing)

Responses from Stanley AAP Board Members Present:

Members welcomed the chance to highlight Stanley's issues which included:

- Poor Shops
- Anti-Social Behaviour
- Traffic Calming
- Education Facilities
- Leisure Facilities
- Tackling Climate Change
- Transport links / Shift Workers
- Mental Health Provision
- Care Academy lack of staff
- A693 Problematic links to A1 Infrastructure

Opportunities

- Could empty shops / premises be maximised is there an opportunity for small business to use them – Business support would be needed from Durham County Council
- Must be aligned to the Masterplan & Levelling Up Bid
- Look at the projects Stanley AAP has funded and feed this in
- City of Culture Use promotion to try to attract GPs and Dentists to Durham

Health & Wellbeing – shortage of GPs and Dentists in County Durham and the North East. Difficult to get an appointment to see a Doctor in the Stanley area.

Local Transport – Stanley is one place that suffers. Getting people home from shift work, no transport.

Education – Look at how the Economy looks like now – those jobs pre pandemic don't exist now. Need to connect with universities and education to align training to the local jobs.

There are a lot of jobs that are not being filled. Lack of confidence in young people.

Need to connect with the AAP Priority survey results.

Glenn highlighted that the consultation website gives more information, contact details, and hosts 3 online surveys:

- One for young people which has been developed with the County's Youth Council.
- One for residents and the anyone who wants to respond.
- And a more tailored survey for businesses this is also available through the Business Durham website.

Glenn also highlighted the extra steps that were being taken to work with colleagues, partner organisations and experts who are advising on how to engage with people who might be missed and adapting the materials we have and methods we're using to try to give everyone the chance to give us their thoughts.

- Late 2022 Adoption of strategy
