

# **Gypsies and Travellers** in County Durham

County Durham has a long history of Gypsies and Travellers living in and travelling through the area. Collectively they form one of the largest minority ethnic communities within County Durham.

**The Equality Act 2010** defines Gypsies and Travellers as a racial group who are protected from direct and indirect discrimination and harassment on the grounds of their race.

Durham County Council is also subject to the Public Sector Equality Duty (PSED). The Equality Duty requires all public bodies to ensure a fairer society by providing equality of opportunity for all, including the need to:

- Eliminate discrimination;
- Advance and provide equality of opportunity; and
- Foster good relations.

GRTS ensure we meet this need through our procedures and day-to-day practice.

# Gypsy, Roma, Traveller and Service Community Cohesion, Safer Communities service

We work with Gypsy, Roma and Traveller communities, local residents, businesses, Elected Members and partners to offer advice and support.

We work on the following principles to:

- To tackle racism, prejudice and discrimination and promote positive race and community relations and community cohesion
- To respect the rights of Gypsy, Roma and Traveller communities to fulfil their cultural needs
- To respect the rights of local settled communities
- To celebrate and promote the benefits that the sharing of cultures and lifestyles brings to wider society
- To value diversity and to treat people fairly with dignity and respect, including recognising that Gypsies, Roma and Travellers needs are not all the same
- To work in an open, fair and clear manner

## **Partnership working**

We work with a range of partners countywide to ensure a joined-up approach to service delivery. This ensures that we can offer clients and customers the most appropriate support, including from partners who have specialist areas of knowledge.

Our service also works with partners regionally and nationally to share good practice and knowledge.

## **Unauthorised Encampments**

An Unauthorised Encampment is when a person or group of people move onto a piece of land they do not own, without the permission of the landowner.

We lead in the response to reports of all encampments on council-owned land in County Durham. This work includes:

Making an initial visit to Unauthorised Encampments on council land which are reported to our service, and making ongoing visits for the duration of the encampments as required.

Deciding if the area is suitable or not.

Liaising with those encamped about the encampment including the reason they are there and, where appropriate, negotiating a length of stay.

Providing information for your Stay in County Durham and discussing this.

Arranging provision of appropriate facilities to ensure identified needs are met, and to try to ensure that each encampment has minimal impact on the area.

Meeting the duty of the local authority to consider the welfare needs of those encamped.

Considering the needs of local communities.

Taking enforcement action where necessary.
