
Notes of the Weardale Area Action Partnership Board Meeting

3. Agreement of Notes from Board Meeting of 21st July 2022 and Matters Arising

4. Presentations:

Community Engagement Review – Maxine Houston, ERS

MH asked the Board for their thoughts on the review. She explained that her role is to listen and not to tell the Board what to do.

MH asked Board members to consider if there are any settlements on the boundary of the WAP area which would identify better as being in Weardale.

Summary of points raised:

- Any change to the name of Area Action Partnerships would be a step backwards. It is now established and recognisable.
- Without the WAP and the associated funding, Weardale would have not been able to access the same amount of funding as other AAP areas.
- The strength of the AAP lies in the depth of local knowledge which was particularly evident during the Covid pandemic.
- The WAP team can deal with any issues that are brought to them or signpost them on as appropriate.
- The team go over and beyond to support residents of Weardale.
- In rural areas, County Hall is a significant distance away. The AAPs enable the council to connect with these areas.
- The AAP overview of all settlements in the area ensures that other people can also find out what is going on.
- AAPs are efficient and provide a mechanism of checks and balances.

The Chair closed the meeting early on receiving the news that Queen Elizabeth II had passed away.
