The Council on 21/6/2024 made the following Minor Order under sections 1, 2, 4, 32 & 35 of the Road Traffic Regulation Act 1984, as amended, which comes into operation on 3/7/2024: The effect of which will a. amend the existing heading Part VIII Contravention and Excess Charges to Part VIII Contravention and Penalty Charge Notices b.to delete existing article 31 and 32 **Contravention & Excess Charges** in its entirety and replace with a new article 31 to read as follows:- **Contravention and Penalty Charge Notice** (31) (1) If a vehicle is in contravention of any provision of this Order a penalty charge shall be payable (2) In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice may then be issued by a civil enforcement officer in accordance with the requirements of section 78 of the Traffic Management Act 2004, as amended. A copy of the Order may be inspected via the Councils website and at Seaham Library during normal opening hours. Any person wishing to question the validity of the Order or of any provision therein on the grounds that it is not within the powers conferred by the Act, as amended, or on the grounds that any requirement of that Act or of any regulation made under it has not been complied with may, within six weeks from 27/6/2024 apply to make an application for that purpose to the High Court.
