Schools are sorted by rank, using the 0.25% transfer option, with 1 being the highest percentage reduction. Other columns in each row show how that school's ranking changes as the transfer percentage increases.

There are 30 secondary schools. Schools are ranked from 1 (the highest percentage reduction) to 28, which is the lowest percentage reduction. The remaining 2 schools are all ranked 29 and are those with no reduction, because they are protected through either the Minimum Per Pupil Level or the Minimum Funding Guarantee.
