The Council on 12/7/2024 made an Order under Sections 1, 2, 4, 32 & 35 & Pt IV of Sch. 9 of the Road Traffic Regulation Act 1984 (“the Act”), as amended, the effects of which come into operation on 25/7/2024 and introduces **No Waiting at Any Time Restrictions on;** **a.Oakfields** on both sides from its junction with Busty Bank in a northerly direction for a distance of 3m each side **b.Busty Bank** on the northern side from its junction with Oakfields in a south easterly direction for a distance of 36m. **c.Busty Bank** on the northern side from its junction with Oakfields in a north westerly direction for a distance of 4m **d.B6310** on the northern side from its junction with Valley View in a westerly direction for a distance of 25m **e.Valley View** on the western side from its junction with the B6310 in a northerly direction for a distance of 9m **f.Valley View** on the eastern side from the existing markings on the B6310 in a northerly direction for a distance of 9m **g. Woodside Road** on the northern side of Woodside Road from a point 42m. west of its junction with St Margaret’s Drive in a westerly direction for a distance of 53m **h.Woodside Road** on the southern side of Woodside Road from a point 42m west of its junction with St Margaret’s Drive in a westerly direction for a distance of 68m. A copy of the sealed Order may be inspected at Stanley Library during normal opening hours & via the Council website. Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by “the Act”, as amended, or on the grounds that any requirement of that Act or of any regulation made under it has not been complied with, may within 6 weeks from 18/7/2024 apply to make an application for that purpose to the High Court.

Part I

1.General

This Order may be cited as The County Council Of Durham Burnopfield, Tanfield, Oxhill, South Moor, Quaking Houses, South Stanley, Craghead and Bloemfontein) (Parking and Waiting Restrictions) (Consolidation No 1) 2017 (Amendment No 1) Order 2024 and shall come into operation on the 25th day of July 2024.

2.Amendments

The following amendments apply to:

Purpose of Amendments

The following brief synopsis of amendments should be viewed in conjunction with the plans identified within the Schedules to the above Order, however the plans should prevail in the event of any discrepancy:

To introduce No Waiting at Any Time Restrictions on:

- a. **Oakfields** on both sides from its junction with Busty Bank in a northerly direction for a distance of 3m each side. (Plan DF192 refers)
- b. **Busty Bank** on the northern side from its junction with Oakfields in a south easterly direction for a distance of 36m. (Plan DF192 refers)
- c. **Busty Bank** on the northern side from its junction with Oakfields in a north westerly direction for a distance of 4m. (Plan DF192 refers)
- d. **B6310** on the northern side from its junction with Valley View in a westerly direction for a distance of 25m. (Plan DD192 refers)
- e. **Valley View** on the western side from its junction with the B6310 in a northerly direction for a distance of 9m. (Plan DD192 refers)

- f. **Valley View** on the eastern side from the existing markings on the B6310 in a northerly direction for a distance of 9m. (Plan DD192 refers)
- g. **Woodside Road** on the northern side of Woodside Road from a point 42m west of its junction with St Margaret's Drive in a westerly direction for a distance of 53m. (Plan DG186 refers)
- h. **Woodside Road** on the southern side of Woodside Road from a point 42m west of its junction with St Margaret's Drive in a westerly direction for a distance of 68m. (Plan DG186 refers)

- h. **Woodside Road** on the southern side of Woodside Road from a point 42m west of its junction with St Margaret's Drive in a westerly direction for a distance of 68m. (Plan DG186 refers)

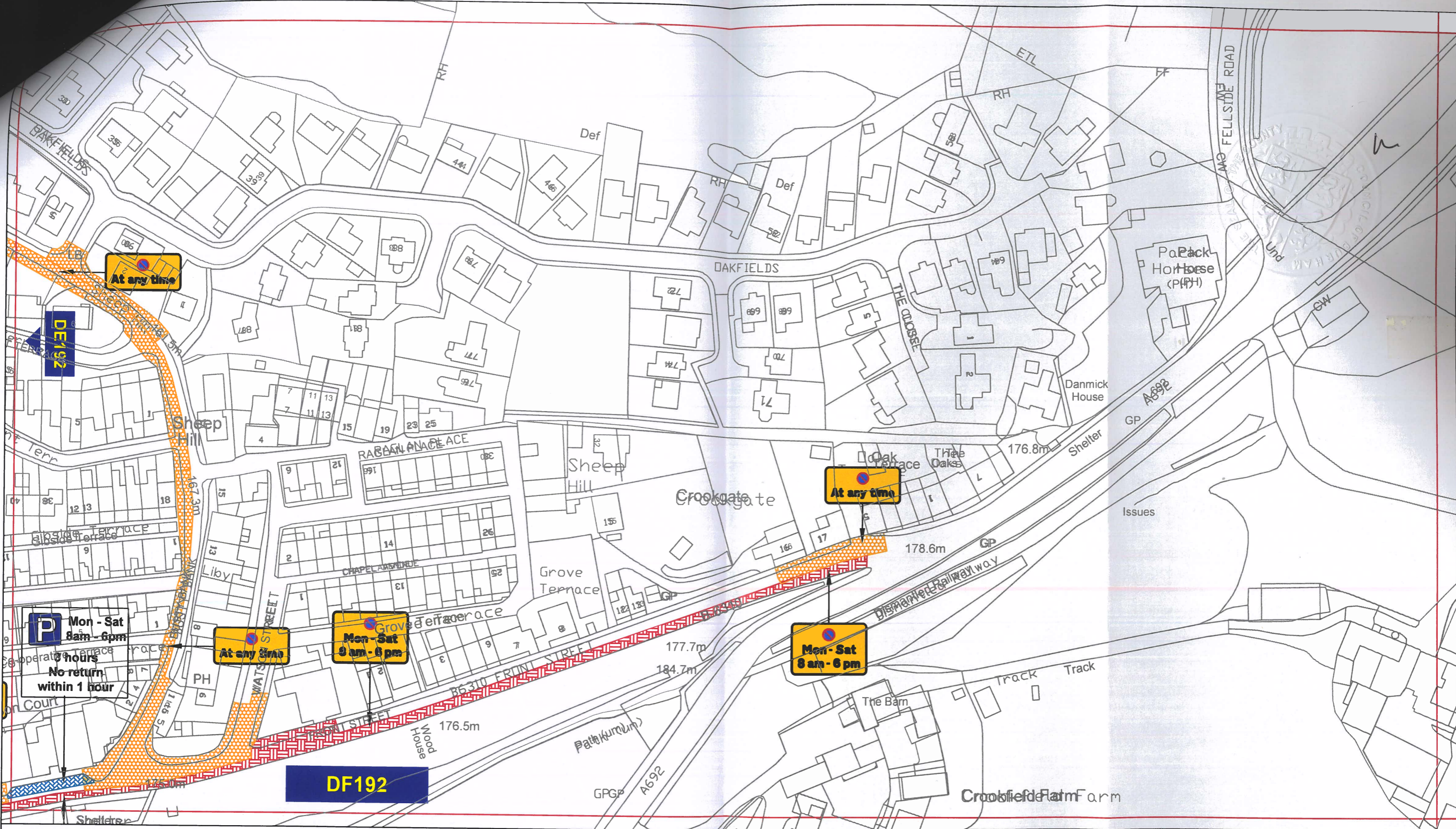
