provisions contained within into this order and also **To introduce ‘No Waiting At Any Time’ restrictions on a.Hay Lane** – on its northern side from a point 5.7m east of the property boundary of Number 5 Hay Lane in an easterly direction for a distance of 6.8m **b.Hay Lane** – on its northern side from the entrance of ‘The Fox Cub’ car park in a westerly direction for a distance of 43.2m. **c.Hay Lane** – on its southern side from the entrance of ‘The Fox Cub’ car park in a westerly direction for a distance of 62.7m **d.Grayson Road** – on its northwestern side extending from the existing ‘No Waiting At Any Time’ restrictions from its junction with Mulberry Drive in a south-westerly direction for a distance of 4.5m **e.Grayson Road** – on its northwestern side extending the existing ‘No Waiting At Any Time’ restrictions from its junction with Mulberry Drive in a north-easterly direction for a distance of 4.5m **f.North Close Road** – on its southwestern side from a point 131.5m southeast of its junction with South View in a south-easterly direction for a distance of 30.3m **g.Rock Road** – on its southwestern side leading from its junction with South View in a southeasterly direction for a distance of 12.7m **h.Rock Road** – on its southwestern side leading from its junction with South View in a north-westerly direction for a distance of 11.8m **i.South View** – on its northwestern side from its junction with Rock Road in a south-westerly direction for a distance of 10.5m **j.South View** – on its southeastern side from its junction with Rock Road in side from its junction with Durham Road in a south-easterly direction for a distance of 4.9m **n.Durham Road** – on its southeastern side from its junction with Cuthbert Street in a south-westerly direction for a distance of 16.7m **o.Durham Road** – on its southeastern side from its junction with Cuthbert Street in a north-easterly direction for a distance of 3.2m **p.Ghent Street** – on its northwestern side from its junction with High Street in a north-easterly direction for a distance of 5.7m **q.Ghent Street** – on its southeastern side from its junction with High Street in a north-easterly direction for a distance of 5.5m **r.High Street** – on its northeastern side from its junction with Ghent Street in a north-westerly direction for a distance of 5.7m **s.High Street** – on its northeastern side from its junction with Ghent Street in a south-easterly direction for a distance of 5.6m **t.High Street** – on its northeastern side from its junction with Wilkinson Street in a north-westerly direction for a distance of 4.8m **u.High Street** – on its northeastern side from its junction with Wilkinson Street in a south-easterly direction for a distance of 22.6m **v.Wilkinson Street** – on its northwestern side from its junction with High Street in a north-easterly direction for a distance of 20.4m **w.Wilkinson Street** – on its southeastern side from its junction with High Street in a north-easterly direction for a distance of 13.8m. **To introduce ‘No Waiting and No loading, Mon-Fri, 8am-9am, 3pm-4pm’ restrictions on a.Durham Road** on its southern side from the entrance of St. Charles’ Catholic Primary School in a westerly direction for a distance of 13.1m **b.Durham Road** on its southern side from its junction with Durham Road (Rear) in a westerly direction for a distance of 3.5m **c.Durham Road** on its southern side from its junction with Durham Road (-Rear) in an easterly direction for a distance of 5.3m **d.Durham Road (Rear)** on its western side from its junction with Durham Road in a southerly direction for a distance of 3.2m **e.Durham Road (Rear)** on its eastern side from its junction with Durham Road in a southerly direction for a distance of 3.2m.**To introduce ‘No stopping, Mon-Fri, 8am-6pm’ on entrance marking restrictions on Durham Road** on its southeastern side from a point 39.7m northeast of its junction with South Terrace in a north-easterly direction for a distance of 68.8m. **To amend existing No Waiting No Loading/Unloading At Any Time bays to Disabled badge holders only, 2 hours not return within 3 hours** on Unc Alnwick Grove on its northern side from a point 22.4m east from the roundabout for a total of three bays.. A copy of the Order and

supporting documents can be seen via the Council website, and at Spennymoor Library during normal opening hours. Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by “the Act”, as amended, or on the grounds that any requirement of that Act or of any regulation made under it has not been complied with in relation to the Order may, within 6 weeks from 18/10/2024.
