Plain)(Temporary Road and Footpath Closure)
Order 2024

The Council on 10/1/2025 made the above Order under Section 14(1) of the Road Traffic Regulation Act 1984 as amended, to prohibit all vehicular and pedestrian traffic from proceeding on the following lengths of road and footpath. **Road closures (closed to vehicular traffic):** **Langley Terrace/Croft Terrace** a 211 metre length from the rear of Number 18 Langley Terrace to the rear of New Kyo Constitutional Club (Number 1 Croft Terrace); **Hawthorn Terrace** a 137 metre length from the rear of Numbers 1 to 26 Hawthorn Terrace; **Sycamore Terrace** a 126 metre length from the rear of Numbers 1 to 24 Sycamore Terrace; **Mulberry Terrace** a 105 metre length to the rear of Numbers 1 to 21 Mulberry Terrace; **Percy Terrace** a 140 metre length to the rear of Numbers 1 to 24 Prospect Terrace; **Meldon Terrace** a 123 metre length to the rear of Numbers 1 to 24 Catherine Terrace; **Dudley Terrace** a 110 metre length to the rear of Number 1/1a to 20/20a Woodbine Terrace; **Unity Terrace** a 229 metre length from the side and rear of Number 1, to the rear and side of Number 33, Unity Terrace; **Edward Terrace** a 185 metre length to the rear of Numbers 1/1a to 30a Coronation Terrace; **Windsor Terrace** a 173 metre length to the rear of Numbers 1 to 29 Windsor Terrace; **Coronation Terrace/Windsor Terrace North** a 99 metre length from the side of Number 1 Unity Terrace to the side of Number 1 Jubilee Terrace; **Mulberry Terrace/Coronation Terrace** an 80 metre length from the side of Number 33 Unity Terrace to the side of Number 29 Windsor Terrace; **Footpath Closure (Closed to pedestrian traffic):** **Unity Terrace** a 12 metre length between Numbers 27 and 28 Unity Terrace to enable water main renewal works to be undertaken. Throughout the period of the closure, alternative routes, where available, will be signposted on site. The maximum duration of the Order is 6 months. The proposed works are to commence from 8am on Monday 20/1/2025 and are anticipated to be completed in 13 weeks. On occasions, alternative dates for the closure may be necessary and these will be signed on site accordingly.
